- The NKK logo will be updated on the JWS switch case, replacing the previous logo. In addition, the material used for the rocker cap is changing. Polyphenylene ether is going to be replaced with polyamide. The flammability rating of the new material is UL94V-2.

These changes will effect both standard and custom products of the JWS Series. The illustrations below depict a standard switch before and after the revisions.
